

2 years GUARANTEE on



STAZO® *marine equipment b.v.* in the Netherlands provides a 2 years guarantee on all MARINEDECK® *interior* planks, strips or tiles provided that:

1. The deck has not been subject to abuse, neglect, accident or to improper installation.
2. The deck has not been subject to another use as it is officially meant for.
3. The deck has not been repaired or altered
4. The owner has the original invoice showing the date of purchase and a specification of the purchased MARINEDECK 2000® *INTERIOR* products.

Conditions of guarantee:

- A. STAZO® *marine equipment b.v.* in the Netherlands warrants each MARINEDECK® *interior* plank, strip or tile for a period of 2 years from the original date of purchase, to be free from any defects of the MARINEDECK® *interior* planks, strips or tiles. The guarantee ends 2 years after the original date of purchase.
- B. Without charge to the customer STAZO® *marine equipment b.v.* in the Netherlands replace any MARINEDECK® *interior* planks, strips or tiles found to be defective within the period of guarantee. Cost of labor concerning any removal or re-installation of MARINEDECK® *interior* planks, strips or tiles is excluded from guarantee.
- C. STAZO® *marine equipment b.v.* assumes no responsibility for the cost of the removal of the product or any other incidental costs which may arise as the result of defect in materials.
- D. STAZO® *marine equipment b.v.* will not be liable for any consequential damages or amount in excess of the purchase price of such damaged MARINEDECK® *interior* plank, strip or tile whether due to the use or installation of the product.
- E. The guarantee is not transferable.
- G. Compensation will never exceed the actual buying price at the moment of purchase
- H. No person or other company, other than STAZO® *marine equipment b.v.* in the Netherlands, is authorized to give any other guarantee or warranty or to assume any other liability in connection with (the sale of) the concerning MARINEDECK® *interior* planks, strips or tiles, as being specified in these present conditions of guarantee.
- I. Warranty is not applicable if detachments or other defects in the work, carried out occur as a consequence of a faulty building structure, an inferior substrate, inferior workmanship or the application of loads that exceed the potential of the products capacity, or that occur while STAZO® or customers of STAZO® have not complied with these directions, or have followed different directions in connection with the work carried out or the use of the products, processed or otherwise, such as included in the TDS, Product Descriptions and Application Guides or as shown on any of the concerning web sites.

Important notes: Any applied coating whether delivered by STAZO® *marine equipment b.v.* or any other third party is explicitly excluded from any guarantee.

Limited guarantee of 5 years on SIMSON MSR products : STAZO® *marine equipment b.v.* in the Netherlands accepts no responsibility whatsoever for any prescribed SIMSON materials. The 5 years limited guarantee on SIMSON materials is provided by Bostik Findley b.v. in the Netherlands in accordance to their terms of limited guarantee and for a period of 5 years after the actual date of purchase. The guarantee is to be reduced by 20% per year after the installation. Compensation will never exceed the actual buying price at the moment of purchase.
